## **TEMPLATE FOR EFFECTIVE NGO/ORGANISATIONAL GOVERNANCE**

Governance, known as *corporate governance* in the business world, is a set of principles, policies, and processes that management uses to run an institution. Governance defines an institution's values while achieving its goals and objectives. Governance is vital in determining how to run a company/organisation. It also helps to instil confidence among donors, participants, and society. A good governance policy and effective management are a trademark of successful institutions.

### **1. Why is Governance Important?**

Most NGOs start small, with day-to-day management, budgeting and operations run by founders using a hands-on

approach. The founders are involved in all matters as financial and human resources are in acute supply.

Ultimately, the NGO grows, and funds and human resources require professional management and guidance. The founders gradually stepped back to allow the management professionals to run the day-to-day affairs. The founders take up the role of board members and overlook the organisation's functioning as the head of a large family would. But this is easier said than done, though. Every so often, the founders maintain interest in day-to-day functioning and thus do not give the professionals a free hand to manage the operations.

Studies show that such conflicts arise due to their fear of loss of organisational spirit and culture and not from a lack of trust in the operational capabilities of management. This is where a good governance policy can help. A governance policy will help define the organisation's culture even after the founders have stepped back or moved on. It will instil confidence in the stakeholders and prevent missteps on the way.

Most NGOs exercise effective governance through an internal system of rules and regulations that describe the roles and responsibilities of the Board members. The board members of the NGO are responsible for establishing the guidelines for the organisation's work.

The Board is at the centre of the governance of NGOs. There are several functions that the Board performs for the successful

management and governance of the NGO. Some of the most critical functions that the NGO board performs include:

- Compliance of the organisation with its Mission and Vision
- Establishing Fundraising Goals
- Assessment of NGO activities
- Establishing policies
- Hiring the executive director
- The financial health of the organisation
- Annual budget and annual work plan
- NGO representation
